



# Time to Act: Strengthening Capacity for Gender Parity in Political Decision- Making in Cyprus

# Capacity Building Workshop for NGOs and Women's Organizations 22-24 April 2016

Civil society can play a key role in mobilizing on a grass-roots level and forming alliances to effectively advocate for more democratic political processes. The aim of the workshop is to promote the engagement and mobilization of civil society to effectively advocate for gender parity in political decision-making at all levels through interactive and participatory training methods, as well as through the development of effective advocacy tools.

The <u>Mediterranean Institute of Gender Studies</u> (MIGS) in cooperation with the <u>National Democratic</u> <u>Institute</u> (NDI) is organizing a capacity building workshop for women's organizations and NGOs active in the promotion of women's participation in public and political life across Cyprus. The capacity building falls within the framework of the project: *"Time to ACT: Strengthening Capacity for Gender Parity in Political Decision- making in Cyprus"*, funded by the Global Women, Peace and Security Initiative (GWPS) of the U.S State Department.

# The objectives of the Capacity Building are:

- Increased understanding of the importance of women in politics and decision-making for achieving gender equality;
- Increased understanding of the link between women's political leadership and positive changes to communities and countries;
- Build consensus on lessons learned from efforts to increase women's political participation in the pastwhat worked/what kept it from succeeding/what should be done differently in an effort to identify strategies for the future;
- Knowledge of strategies for a successful advocacy campaign to promote increased women in political leadership positions;
- Building core advocacy skills needed to achieve gender equality goals for women in political leadership;
- Setting a draft set of priorities to develop formal or informal coalition and advocacy and outreach plan.

## **Profiles of trainers and facilitators**

### Caroline Hubbard, Senior Program Manager, Women's Political Participation

Caroline Hubbard is the program manager for women's political participation at the National Democratic Institute for International Affairs (NDI), where she works to support the aspirations of women around the world to be equal and active partners in shaping and leading democratic societies. Although Caroline works across all regions, she is particularly focused on Africa and the Middle East. NDI's creative and wide-ranging programs engage women in legislatures, political parties and civil society as leaders, activists and informed citizens. Prior to joining NDI, Caroline was a program manager for Vital Voices Global Partnership, where she executed international training programs aimed at empowering emerging women leaders, including projects in Central and Eastern Europe and Eurasia, the Middle East and North Africa, and Sub-Saharan Africa. Caroline has also worked to support women's rights and democracy in the US and around the world in the Office for Democracy and Global Affairs at the U.S. Department of State and at the American Association of University Women.

### Angela Short, Senior Program Officer for the Middle East and North Africa

Angela Short is a Senior Program Officer for the Middle East and North Africa at the National Democratic Institute for International Affairs (NDI) based in Washington, DC. Since joining NDI in 2009, Angela has supported a breadth of programs throughout the MENA region, including: leadership development for youth activists across the Maghreb; women's political participation strengthening in Mauritania; political party and legislative capacity building in Tunisia; and citizen advocacy around the inclusion persons with disabilities in the West Bank. She also has experience with elections programming, contributing to a national voter education program in Mauritania in 2012, and international election observation missions in Algeria in 2013 and in Tunisia in 2011 and 2014. Prior to joining NDI, Angela worked at Management Systems International (MSI) in Washington, DC and for an Egyptian charity organization in Cairo. She holds a bachelor's degree in political science and Arabic from Georgetown University. She attended the American University in Cairo (AUC), and studied Arabic at the International Language Institute (ILI) in Cairo and the Arabic Language Institute in Fez (ALIF).

#### Sonja Lokar, Sociologist and feminist activist

Sonja Lokar is a sociologist, politician and feminist activist from Slovenia with expertise in political party development, social welfare state issues and gender issues. She was tasked to organize the transformation of the social democratic party (1986-1990) and served as secretary general of her party in 1990. Sonja was elected as a Member of Parliament from 1986-1992 and was founder and president of the women's forum of her party for ten years. She was also one of the initiators and Chair of the Stability Pact Gender Task force (1999-2009) and was executive director of the CEE Network of Gender Issues from 1998. She was elected in 2012 as President of the European Women's Lobby and has served as president of the Women's Lobby of Slovenia since 2015. As an active researcher and political analyst, she has published more than 300 articles in Slovene, Croat, English, French and German languages, and has co-authored several 'Women Can Do It' train the trainer manuals. She cooperates with various organizations (incl. OSCE, WB, NDI training programs and election observation missions).
